QPWB ATTORNEY TO SEEK DAMAGES UNDER THE TEXAS DECEPTIVE TRADE PRACTICES ACT IN EXCESS OF \$1 MILLION ON BEHALF OF VICTIMS OF ILLEGAL PRACTICES

CONSUMER RIGHTS

Quintairos, Prieto, Wood & Boyer, P.A., (QPWB) represents seven Hispanic families in Fort Worth, Texas who are victims of a fraudulent scheme perpetrated by a man named Jose Rios. Rios leased the St. Joseph's Hall facility to families for quinceañeras or wedding receptions. Rios engaged in a pattern of double or triple-booking the dates of the events, and just before the dates of the events he contacted the parties and informed them the events had to be cancelled for bogus reasons. Some examples of the false reasons he gave include claiming the fire marshal shut down an event because of compliance issues, claiming a local district judge ordered an event to be shut down over the county's concerns of underage drinking, and claiming an event had to be shut down because he allegedly contracted COVID-19. To support his fraudulent schemes, Rios produced documents which he clearly altered to make his claims appear legitimate. The families paid between \$6,000 and \$26,000 to lease the facility. When the families asked for their money back, Rios refused. To date, he has withheld over \$100,000 of money given to him by these families for the lease of the facility.

After taking the case, QPWB attorney **Steven A. Wood** worked with the local district attorney's office to assist them in bringing criminal charges against Rios. Rios was subsequently indicted and arrested on three counts of tampering with a government document with the intent to commit fraud. The district attorney is currently working to bring charges against Rios for theft. Mr. Wood is also preparing to file suit against Rios and the owner of the property where St. Joseph's Hall is located. The lawsuit will seek damages and attorney's fees under the Texas Deceptive Trade Practices Act in excess of one million dollars.
